Consent to using your child's images will last throughout your child's time at the school and will continue to apply for a short time after they leave (except for images published for historical purposes which may be kept for an extended period of time to show the history of the school).

You can withdraw your consent at any time by sending an email to info@westfield.surrey.sch.uk asking the school to stop using your child's images. At that point they will not be used in future publications or videos but we cannot prevent them from continuing to appear in publications and videos already in circulation.

I also agree that any photographs or videos taken by myself or my family members at school events will be kept for personal/family use only and will not be uploaded onto any social networking or online sites.
